INTRODUCTION

The introduction answers commonly asked questions of the ACICS Campus Accountability Report (CAR). This section also includes a summary of the significant improvements introduced in July 2014 to the submission procedures.

Following the introduction we have provided guidelines for the web-page requirements, guidelines for completing the program measurement data section of the spreadsheet and student population data section of the spreadsheet, the calculated results table, and the formula's used for calculating the data.

Who Needs to Submit an ACICS Campus Accountability Report (CAR)?

The CAR is a yearly requirement separate and apart from any evaluation process. Any accredited campus (main and branch) that was accredited prior to the CAR reporting year (July 1, 20XX to June 30, 20XX) are required to file a CAR. Each campus has an obligation to follow the

instructions and guidelines to ensure the report was complete and successfully submitted. Assurance of a complete and successful submission is the sole responsibility of the campus.

What is the CAR reporting year?

ACICS CAR reporting year is July 1, 20XX to June 30, 20XX. The CAR is commonly referred to using the submission year (e.g., 2014 CAR includes student population data collected from July 1, 2013 to June 30, 2014 and submitted November 3, 2014).

What data can be included on the CAR through the submission date in November?

Student population data MUST reflect the CAR year (July 1, 2013 to June 30, 2014). However, **placement data** for graduates and completers reported on the current year's CAR are acceptable up to **November 1, 2014**.

What is the 2014 CAR Submission Date?

The CAR must be submitted by close of business Monday, **November 3, 2014**. It is the responsibility of the campus to correct any errors discovered by the institution or requested by Council. A **\$250 Revision Fee** is charged for revisions made after November 3, 2014. No exceptions will be made.

A **\$500 Late Fee** will be assessed for reports not submitted by **November 3, 2014**. Extensions will only be granted for extreme extenuating circumstances.

Improvements Effective July 1, 2014

Recognition of Main Campus and Corporate Login

Effective with the 2013-2014 CAR submission, the system functionality was improved to provide access to all institutional locations (main and branch campuses) if the end-user logs on as the corporation. Similarly, if the end-user logs in with the main campus credentials, they will have access to the main campus and any branch campus within that institutional grouping.

In addition, the web questions have been simplified and the system will self-calculate the data from spreadsheets (modeled after a standard back-up spreadsheet). To successfully record program data and roll-up program level data to the campus level, each specific system-generated program spreadsheet **MUST** be downloaded from the zip file in the member portal and used. The zip file that institutions download will house all programs that were active during the CAR reporting period. The nomenclature of the program spreadsheets located in the zip files is as follows: i.e. **00012345_Accounting_04_034505** (Institution Id Code_Program Name_Program Credential Level_Application Id_Unique Program Id). **Do not rename the program spreadsheets. Institutions cannot "copy" a program spreadsheet from one campus and use for another, or copy a spreadsheet and use as a template.**

Placement Definition

Reporting placement data in the three categories remains optional for the 2014 CAR. The 2014 CAR is designed to accommodate reporting in the three placement categories. If institutional data was not captured to align with the three categories, institutions may place information in any one of the three categories.

To Request Adjustments to the Program Zip File

Please check the list of programs in the zip file that you download. Programs that appear the zip file but were discontinued prior to July 1, 2013, and should be removed, please send an email message to PAR@acics.org using the heading “Program Discontinuation Request” and include the name of the program, credential level, total credits awarded, total clock/credit hours and program length, and the official discontinuation date (the date by which active students were no longer enrolled in the program).

All approved programs can be viewed on the ACICS Web site through the Member Portal, “My Account>Accredited Programs” tabs. Forms for requesting approval of changes to programs are available on the Web site under the “Accreditation>Applications and Forms” tabs. Once the institution has been notified that the requested program changes have been made the institution **MUST** download the zip file again.

WEB-PAGE GUIDELINES

Login

The ACICS Campus Accountability Report (CAR) is accessed through the membership portal using the campus login credentials. If the end-user logs in using the corporate credentials, they will have access to any campus under that corporate structure. If the end-user logs in as a main campus, they will have access to submit the CAR on behalf of the main campus and any branch campus within that institutional grouping.

From the left side menu selection, click on **CAR**.
