Dear Ms. Fielder:

The Council has reviewed your most recently submitted 2017 Campus Accountability Reports (CAR) for the **Clarksville, TN**, and **Greenville, NC**, campuses, and the reported campus-level placement rates of **47%** and **36%** respectively, do not meet the Council's standard of 60%. The Council has also taken under consideration that the institution will be ceasing all instructional activity no later than **May 27, 2018**.

### **Council Action**

Therefore, the Council acted to place the institution on **compliance warning** for the below-standard results for 2017, through the cessation of academic activity at the institution. In the interim, the institution is required to submit updates on the progression of current enrollments. These updates, including Part II of the Campus Closure Application, are to be uploaded to the preexisting campus closure application in the Member Center and indicate, by student, those that will complete prior to May 27, 2018; those that will transfer elsewhere; and those that are choosing not to complete their programs. The institution must also provide any executed teach-out agreements for the Council's review and approval.
